### **PARENT/GUARDIAN AGREEMENT**

I, the parent/guardian of the registrant, a minor, agree that the registrant and I will abide by the rules of soccer and in consideration for the MYSA accepting the registrant for its soccer programs and activities (the "Programs"). I hereby release, discharge and/or otherwise indemnify the MYSA, its affiliated organizations and sponsors, their employees, and associated personnel, including the owners of field and facilities utilized for the Programs, against any claim by or on behalf of the registrant as a result of the registrant's participation in the Programs and/ or being transported to or from the same, which transportation I hereby authorize.

### **PLAYER TRANSFER RELEASE**

1. Any player signing a player registration form to play on a team is bound to that team for the entire soccer year unless the player requests a transfer and the transfer is approved. A request for transfer must be made in writing relating the reasons with copies being sent to the coach, club or association president, and league director who will make a determination. This decision can be appealed following the appeal process of MYSA. Player transfers may only be approved for the following reasons:
  - a. Player relocates to a different community.
  - b. Voluntary release by club.
  - c. Player's desire to play at a higher level which is not available at current club.
2. Any player whose team completes its schedule, including tournaments, cup play and exhibitions, may transfer to another team during the soccer year.
3. No team may be permitted to drop more than three players during a soccer year.
4. The league registrar and/ or the league director must be notified of a dropped player.
5. A team is limited to a total of three transferred players per soccer year.

### **REFUND POLICY**

**No refund will be given without a written request from the parents.** Refunds: \$25 is considered non-refundable to cover administrative costs and expenses. Any player signing up but withdrawing will be assessed this charge. If a player drops after registration close date, January 31, 2010, and before submittal of teams to MYSA, April 1, 2010, only half of the fees can be refunded ; but if a player drops after submittal to MYSA, no part of the summer fee is refunded.
